**Sub.: Regarding segregation of Mangalam DAV Public School, Aditya Nagar, Morak, Kota, Rajasthan from DAV College Management Society**

Sir,

This has reference to the MoU dated 30.04.1996 signed between the DAV Trust & Management Society referred to as the "Society" and the Mangalam Cement Limited called the "Enterprise" for running a school on 100% self financed basis. Now an Agreement entered into for segregation of Mangalam DAV Public School, Morak from DAV College Management Trust & Society (copy enclosed). Vide agreement, it is decided that Mangalam Cement Limited would like to run the school at their level and DAVCMC, New Delhi will no longer be responsible for anything at all legally.

In anticipation of the following terms, NOC is being issued on this day i.e. 05.12.2022:-

- The staff will be paid their wages and all other benefits including retirement benefits by Mangalam Cement Ltd.
- You will refrain from using the mark DAV or D.A.V. in the name of the school.
- You shall remove these words DAV or D.A.V. within one month from the receipt of this letter and will issue notice in this regard atleast in two local newspapers that you are changing the name of the school by removing these words.
- You will also inform the students and parents in this regard by issuing circular and through your website.
- It shall be the responsibility of Mangalam Cement Limited to inform the CBSE about the disassociation of the school from DAV College Managing Committee, New Delhi on immediate basis.
- You will remove signboards with this mark i.e. DAV or D.A.V.
- All the pamphlets, letter heads, visiting card or any other document having such name shall also be destroyed within one month from receipt of this letter.
- The property of the school as on basis, which belongs to the Mangalam Cement Ltd. has been returned to the Mangalam Cement Limited through Chairman LMC Shri Sunil Sachan and Shri Anil Kumar Mandot, Member LMC.
- Cheque No. 268032 dated 05.12.2022 amounting to Rs. 52,51,346/- (Rupees Fifty Two Lacs Fifty One Thousand Three Hundred Forty Six Only) has been received against dues payable to DAV College Managing Committee, New Delhi through Shri Sunil Sachan, President Mangalam Cement Limited and Chairman LMC Mangalam DAV Public School, Morak, Kota, Rajasthan.
